1. Applicant/accused Bano has filed present interim bail application for grant of bail for 30 days. It is stated in the application that accused has medical issues and she has to take care of her minor grandchildren. Counsel for complainant has opposed the said application by stating that the allegations in the FIR in question are serious. Ld. Addl. P.P. for the State has also opposed the bail application by referring to the contents of the FIR in question. IO has also opposed the bail application.

2. Arguments heard. Record perused.

3. Report from jail superintendent also perused and considered.

As per report of jail superintendent, applicant/accused is suffering from certain disease of Diabetes Mellitus II/Left sided Renal stone/sleep disorder. She is 58 years old. In the report filed by the IO, it is stated that minor grandchildren of accused are being taken care by relatives and neighbours. Chargesheet in this case has been filed. Parents of children are also languishing in jail. In these circumstances, applicant/accused Bano is admitted to interim bail subject to furnishing of personal bond in sum of Rs.20,000/- with one surety in the like amount.

4. Further, this order entails following conditions :-

a) Applicant shall not leave the jurisdiction of Delhi, after reaching Delhi, (as presently she is outside India), without informing SHO concerned



in writing, giving details of the place she is going and the time for which she will be out of Delhi.

b) Applicant shall keep her mobile phone in switch on mode, all the time by furnishing its details to the IO concerned, in writing within three days from now.

c) In case, she changes her mobile number, then she will inform the IO concerned in writing, within one day of said change.

d) Applicant shall not try to meet complainants and/or their family members till the adjudication of this case.

e) Applicant shall not threaten complainant physically or verbally through any electronic mode.

f) Applicant shall specify the exact address where she is residing to the IO, so that IO can meet her, if situation so demands. In case of change of residence, applicant shall notify the IO in writing, immediately, within two days of said change of residence.

5. Accused is directed to surrender before this Court before 5.00 PM on 10.06.2022. Accused is accordingly granted interim bail for 30 days, as mentioned above.

6. Release warrants be prepared, subject to furnishing of personal bond and surety bonds, as directed above.

7. Present application for interim bail accordingly stands decided.

8. Copy of this order be sent to Jail Superintendent, Tihar for the necessary intimation and for the communication to the accused Bano. Copy of the order be given dasti, as prayed.
