1. Petitioner seeks interim bail for eight weeks on the medical grounds as he is suffering from various ailments. The report dated 02.12.2022 of the Medical Officer In-Charge, Central Jail No.4, Tihar, New Delhi inter alia notes:-

At present inmate patient is a follow-up case of CAD, for which he had been kept admitted in MI room for observation quite a few times in recent past, been admitted in ICCU, DDU hospital and referred to department of Cardiology, GB Pant hospital as well, wherein on the basis of findings of 2D-ECH0 and CT- coronary angiography (done on 03/11/2022) he has been advised for coronary angiography (+/- PTCA) on latest visit on 29/11/2022.

Further inmate patient is a case of lower urinary tract syndrome, post TURP and currently under treatment from department of Urology, Safdarjung hospital (recent urine c/s report suggestive of severe urine infection), bronchial asthma with on and off acute exacerbation, bleeding per rectum for which he is receiving treatment by Doctor on duty/Jail visiting SR/DDU/Safdarjung Hospital/GB Pant hospital.

2. Thus, above report shows not only the petitioner is suffering from heart ailment, but also severe urine infection, bronchial asthma and bleeding per rectum and is receiving treatment by doctor. It is submitted the

petitioner is in custody since 02.01.2021 and needs urgent proper treatment and care.

3. In the circumstances, the petitioner is granted interim bail for a period *eight* weeks from the date of his release on his furnishing personal bond in the sum of Rs.25,000/- with one surety of the like amount to the satisfaction of the learned Trial Court/Duty Magistrate. The petitioner is also directed to provide his contact number/ address to the SHO concerned as also he shall keep open his location application in his mobile at all time. The residential address of petitioner where the petitioner would be staying during interim bail period be got verified by the learned Trial Court. The petitioner shall not indulge in similar activities during interim bail period. The petitioner shall surrender on expiry of interim bail and shall not seek extension thereof.

4. The petition stands disposed of in above terms. Pending application, if any, also stands disposed of.

5. Copy of this order be sent electronically to the learned Trial Court / Jail Superintendent for information and compliance. Order *dasti*.
