- 1. This petition is for grant of bail to the petitioner.
- 2. The allegations are he shared the bank details of the complainant Kanika Girdhar to his associates, the co-accused persons who then got issued a cheque book and ATM card in the name of complainant by forging her signatures and thereafter took away Rs.01.35 crores lying in her bank account.
- 3. It is submitted the matter- has been amicably settled between the parties and the bank has already paid Rs.1.37 crores to the complainant and even the ICICI Bank has entered into MoU/Settlement Deed dated 11.07.2022 for a total sum of Rs.1,35,83,589/- with accused person out of which Rs.67.00 lacs has been repaid to the ICICI Bank and rest of the amount has to be paid by co-accused Shailender Pratap Singh once he

comes out of jail.

- 4.
