 - (a) Allow the present petition and may issue appropriate Writ/Direction /Order in order to provide police protection to the petitioners by which the respondent no. 2 and other anti-social elements may not cause any harm to the life and property of the petitioners.
 - (b) May take any other appropriate action against respondent no. 2 for taking the laws in their hands.
- 6. This petition is filed for providing protection to the petitioner from

respondent No.2 at the address mentioned.

- 7. The allegations are in the year 2016, the petitioner has taken a loan of Rs.50,000/- from the respondent no. 2 and has been paying interest on that but despite paying a huge amount, the respondent No.2 continue charging higher interest and has threatened the petitioners using abusive and derogatory language. On 14.09.2021 respondent No.2 along with anti-social elements had entered into the residence of the petitioners and had brutally and mercilessly beaten petitioner no.2. On 17.09.2021 the respondent No.2 has forced the petitioner to sign an agreement making him liable for Rs.2.75 lacs. It is stated clause 3 of the agreement is cleverly drafted to save respondent No.2 who had beaten mercilessly the petitioners herein. In the circumstances, the petitioners be provided with mobile numbers of the division officer/beat staff so that in case of any emergency, they may be contacted for any help.
- 8. Learned counsel appearing for learned ASC on advance notice seeks time to file status report/reply. Be filed before the next date of hearing with an advance copy to learned counsel for the petitioner.
- 9. Issue notice to respondent No.2 by all modes returnable on 22.02.2022.
